Cimarex proposes perf and acidize the Cisco 10302-10599'. Perf and acidize the Wolfcamp 9100-10302'. Allocation percentages for each zone will be based on production log.

It is anticipated that the reservoir pressure from these two shale zones will be compatible and the resulting volumes would not warrant a casing/tubing dual completion.

Royalty, overriding royalty, and working interest owners are the same in each zone.




