Gentlemen:

Chevron U.S.A. Inc. respectfully requests your approval of this administrative application for Simultaneous Dedication.

Chevron is planning to drill and complete the Theodore Anderson #11 in the Eumont Yates 7 Rvrs Qn (Pro Gas) Pool. It is our desire to simultaneously dedicate the existing 240-acre Eumont Gas Proration Unit currently assigned to our Theodore Anderson #4 and Theodore Anderson #7 [Administrative Order R-6410 and Administrative Order NSP-129] to all three wells. The 240-acre gas proration unit comprises the W/2 of the NW/4 and all of the NE/4 of Section 17, T-20-S, R-37-E, Lea County, New Mexico. As the Theodore Anderson #4 and #7 are producing at a current rate of 990 MCF/D, the proposed new drill of Well #11 will essentially capture reserves which otherwise would not be produced from this GPU.

Chevron respectfully requests your approval of this administrative application for simultaneous dedication. Attached is a vicinity map, location verification map and a Form C-102 plat.




VOLUME MAP
