Gentlemen:

Great Western Drilling Company hereby submits its application for administrative approval of a non-standard gas proration unit comprising All (Lots 1, 2, 3, and 4, SE/4 SW/4, S/2 SE/4, SW/4 SW/4) of Section 12, Township 32 North, Range 12 West, N.M.P.M., San Juan County, New Mexico, and in support thereof states the following facts:

1. The Great Western #2 Decker well, located 1850 feet from West line and 990 feet from South line of Section 12, Township 32 North, Range 12 West, was completed as a gas well on July 29, 1954, and connected to El Paso Natural Gas Company line on October 6, 1954.
2. That the proposed non-standard gas proration unit consists of 336 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.




