Gentlemen:

Reference is made to your letter of April 16, 1955, regarding the Carroll-Hannett Wells No. 1 and No. 2, in the Fulcher Kutz-Pictured Cliffs Gas Pool, owned by Claude M. Carroll, Dr. J. W. Hannett, and yourself.

Records at this office indicate an apparent confusion or conflict in the dedication of acreage to wells in Sections 33 and 34, Township 30 North, Range 12 West, San Juan County, New Mexico.

With reference to your Carroll-Hannett Well No. 1, located NW/4 SW/4 of Section 34, Township 30 North, Range 12 West, of the 160 acres which you propose to dedicate to this well, the E/2 SW/4 of Section 34 is dedicated to the Aztec Oil and Gas Company's McGrath Well No. 2, located in the SE/4 SW/4. Therefore, it would appear that the only acreage available to be dedicated to your Carroll-Hannett Well No. 1, is the W/2 SW/4 of Section 34, the same being 80 acres.

As for the Carroll-Hannett Well No. 2, located in the NE/4 SE/4 of Section 33, Township 30 North, Range 12 West, there are two wells located on the acreage which you propose to dedicate to your Carroll-Hannett Well No. 2. Your Well No. 2 is offset to the west by the M.S.B.W. Company's Maddox-Hargis Well No. 2, located in the NW/4 SE/4 of Section 33, Township 30 North, Range 12 West, and offset to the south by the Three States Natural Gas Company's Hudson Well No. 1, located SE/4 SE/4 of Section 33, Township 30 North, Range

12 West. Therefore it would appear that the only possible dedication of acreage to your Well No. 2 would be the NE/4 SE/4 of Section 33, the same being 40 acres.

I enclose memoranda which will assist you in the filing of your applications for approval of these non-standard gas proration units, and I would like to advise you further that said applications must be received at this office by May 1, 1955, for said wells to remain on the Northwest Gas Proration Schedule.

Gentlemen:

Claude M. Carroll, Dr. J. W. Hannett, and I own two wells in the Fulcher Basin area, San Juan County, New Mexico. They are known as the Carroll-Hannett wells numbered 1 and 2.

I understand that although we own the mineral rights to some 480 contiguous acres, the acreage is not spaced so that either well is on a 160-acre tract, and that we should make application for the wells to be continued to be operated on what is known as a non-standard unit well. These wells were drilled more than ten years ago and have been producing ever since.

This letter is addressed to you for the purpose of requesting you to send us any blanks or instructions necessary to comply with the law and your regulations.

Regarding Carroll Hannett #1 well, application is hereby made for administrative approval of the non-standard unit dedicated to this well. This request is made in accordance of the following rules and regulation, Order R565 rule 6A and 6B.
