Please correct Administrative Order NWU-90 dated May 25, 1955 to read as follows:

Reference is made to your application for approval of a 293.84-acre non-standard gas proration unit in the Blanco-Mesaverde Gas Pool consisting of the following:

It is understood that this unit is to be ascribed to your Jones Well No. 1-A, located 800 feet from the South line and 1550 feet from the West line of fractional Section 10, Township 28 North, Range 8 West, NMPM, San Juan County, New Mexico.

By authority granted me under provisions of Rule 1, Section (b) of the Special Rules and Regulations for the Blanco-Mesaverde Gas Pool, as set forth in Order R-128-C, you are hereby authorized to operate the above described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with pool rules, based upon the unit size of 293.84 acres.
