of Order No. R-128-C for Non-Standard
Proration Unit, Blanco Mesaverde Gas
Pool, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard unit comprising the South Half (S/2) (or SE/4 SE/4, SW/4 SE/4, SE/4 SW/4, SW/4 SW/4, Lots 1, 2, 3, and 4) of Section 11, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Jones #2-A Well, located 1150 feet from the South line and 890 feet from the West line of Section 11, Township 28 North, Range 8 West, San Juan County, New Mexico, was completed as a gas well on March 10, 1955.
2. That the proposed non-standard gas proration unit consists of 291.96 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


