of Order No. R-565 for Non-Standard
Proration Unit, Aztec-Pictured Cliffs
Gas Pool, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for an administrative approval of a non-standard proration unit comprising the Southwest Quarter (SW/4) (or Lots 3, 4, NE/4 SW/4, SE/4 SW/4) of Section 7, Township 29 North, Range 10 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Hubbell #1 Well, located 890 feet from the South line and 890 feet from the West line of Section 7, Township 29 North, Range 10 West, was completed as a gas well on January 3, 1952, and connected to El Paso Natural Gas Company's gathering system on November 13, 1952.
2. That the proposed non-standard gas proration unit consists of 154.00 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.




