of Order No. R-128-C for Non-Standard  
Proration Unit, Blanco Mesaverde Gas  
Pool, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the West Half (W/2) (or SE/4 NW/4, NE/4 SW/4, SE/4 SW/4, Lots 3, 4, 5, 6, 7.) of Section 6, Township 30 North, Range 11 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Yager Pool Unit #2 Well, located 1090 feet from the North line and 1090 feet from the West line of Section 6, Township 30 North, Range 11 West, was completed as a gas well on September 30, 1953, and connected to El Paso Natural Gas Company's gathering system November 15, 1953.
2. That the proposed non-standard gas proration unit consists of 328.17 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


