Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the W/2 (Lots 1, 2, N/2 SW/4, NW/4) of Section 32, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Phillips #1 Well, located 890' from the South line and 800' from the West line of Section 32, Township 28 North, Range 8 West, was completed as a gas well from the Mesaverde Formation on October 26, 1956.
2. That the proposed non-standard gas proration unit consists of 305.87 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That a copy of this letter of application was not sent to any other operator inasmuch as El Paso Natural Gas Company owns all working interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit.




