Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the Southeast quarter (SE/4) or (NW/4 SE/4, NE/4 SE/4, Lots 6,7) of Section 31, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Schwerdtfeger #7-A Well, located 680' from the South line and 852' from the East line of Section 31, Township 28 North, Range 8 West, was completed as a gas well on October 19, 1956, and as yet, has not been connected to El Paso Natural Gas Company's gathering system.
2. That the proposed non-standard gas proration unit consists of 144.80 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company is the owner of all the interest in Section 31, Township 28 North, Range 8 West, and El Paso Natural Gas Company is the owner of all the interest in acreage offsetting the proposed non-standard proration unit.

Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 6 (b) Revised of Order No. R-565, the Secretary of the Commission grant exception to Rule 6 (a) without Notice and Hearing, and approve the subject non-standard gas proration unit.


