Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the southwest quarter (SW/4) or (Lots 3 and 4, E/2 SW/4) of Section 19, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:


1. The Florance #3-C Well, located 1450' from the South line and 1750' from the West line of Section 19, T-28-N, R-8-W, was completed as a gas well from the Pictured Cliffs Formation on October 7, 1957.
2. That the proposed non-standard gas proration unit consists of 152.44 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company is the owner of all the interest in Section 19, Township 28 North, Range 8 West, and El Paso Natural Gas Company is the owner of all the interest in acreage offsetting the proposed non-standard proration unit.

Therefore, El Paso Natural Gas Company requests that under the provision of

Rule 6(b) Revised of Order No. R-565-C, the Secretary of the Commission grant exception to Rule 6(a) without Notice and Hearing and approve the subject non-standard gas proration unit.


