Rio Arriba County, New Mexico.

Magnolia Petroleum Company hereby applies for administrative approval
for a non-standard gas proration unit for the Jicarilla "B" No. 1
within the Tapacito Pictured Cliff Gas Pool. The well location,
legal description of the proration unit sought, and acreage there-
in are:

Requisite forms for well operation on file with the Commission re-
flect 160 acre attribution for this well. A subsequent investi-
gation of Magnolia's records reveal that these forms, inad-
vertently filed, are in error by the amount set out above. The
error results from well location within a non-standard govern-
mental section.

Magnolia through this application seeks to correct acreage at-
tribution to the Jicarilla "B" No. 1 by a request for a non-
standard proration unit. Approval is requested under administrative

authority granted to the Secretary-Director under Rule 2(b) of Order No. R-1193, Special Rules and Regulations for the Tapacito Pictured Cliff Gas Pool.

Such facts do exist and provisions have been complied with to make Rule 2(b) applicable. These are:

- (1) The requested unorthodox unit consists of less than 160 acres due to a variation from the conventional size in the governmental section in which the well is located.
- (2) The requested non-standard unit consists of contiguous quarter-quarter sections.
- (3) The requested non-standard unit lies wholly within a governmental section.
- (4) The requested non-standard unit may reasonably be assumed to be productive of gas in its entirety.
- (5) All acreage within the requested non-standard unit is under a lease granted to Magnolia Petroleum Company.
- (6) In lieu of Section (b) subparagraph (5) of Rule 2(b), the applicant attaches and makes a part of this application a copy of the letter sent by registered mail to the only known offset operator, Southern Union Gas Company, Dallas, Texas. This letter includes a copy of this application and requests Southern Union to make any objections to this application known to the Commission within 30 days of receipt.
- (7) This application is intended to apply to the Pictured Cliff formation only.

Plats showing the acreage requested for attribution and location of the Jicarilla "B" No. 1 are attached and are meant to constitute a part of this application.

The applicant, Magnolia Petroleum Company, having determined that the unit acreage requested will conform to Rule 2(b) Order R-1193

and having complied with requirements of this rule, hereby respectfully requests administrative approval for a non-standard proration unit for the Jicarilla "B" No. 1.




