Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the S/2 and Lots 1, 2, 3 and 4 (All) of Section 12, Township 32 North, Range 7 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Allison Unit #13 Well, located 890' from the South line and 950' from the West line of Section 12, Township 32 North, Range 7 West was completed as a gas well from the Mesaverde Formation on July 16, 1958.
2. That the proposed non-standard gas proration unit consists of 399.00 acres, which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That El Paso Natural Gas Company and Amerada Petroleum Corporation are the owners of all the leasehold interest in Section 12, Township 32 North, Range 7 West, and El Paso Natural Gas Company and Amerada Petroleum Corporation are the owners of all the leasehold interest in acreage offsetting the proposed non-standard gas proration unit.




