Gentlemen:

The recent Dependent Resurvey of Township 30 North, Range 8 West, accepted by the Bureau of Land Management in 1959, revised certain of the acreage secured under Delhi-Taylor Federal leases affecting thereby the above captioned Mesaverde Units in which said acreage is included.

As you will note by examination of the attached plats which depict the affected units prior and subsequent to the Resurvey, the revision of the acreage comprising said units, either by inclusion or deletion, resulted in the creation of non-standard proration units.

As illustrated by the attached plats, the wells affected are as follows:

Howell #1 Mesaverde Well located in SW $\frac{1}{4}$, Section 20

Howell #2 Mesaverde Well located in NE $\frac{1}{4}$, Section 10

Howell #3 Mesaverde Well located in NE $\frac{1}{4}$, Section 30

Linda Nye #1 Mesaverde Well located in NE $\frac{1}{4}$, Section 20

Florance Federal #46 Mesaverde Well located in NE $\frac{1}{4}$, Section 29

Archuleta #1 Mesaverde Well located in SW $\frac{1}{4}$, Section 19

The proration unit for the Howell #1 decreased from 320 acres to 267.50 acres; Howell #2 increased from 320 acres to 330.30 acres; Howell #3 decreased from 320 acres to 290.69 acres; Florance Federal #46 decreased from 320 acres to 287.18 acres; Linda Nye #1 decreased from 320 acres to 311 acres; and the Archuleta #1 increased from 337.30 acres to 342.54 acres.
