

Pursuant to Rule 5(B) of Order R-1670, Aztec Oil & Gas Company hereby submits its Application in triplicate for an exception to Rule 5(A) of subject Order and Administrative Approval of a Non-Standard Unit consisting of Lots 5, 6, 11, and 12 of Section 31, T-29-N, R-9-W, N.M.P.M., San Juan County, New Mexico.

In support of this Application, Applicant respectfully states and shows the following:

1. A location has been staked one thousand one hundred and ninety feet (1190') from the North line and one thousand seven hundred and thirty feet (1730') from the East line of Section 31 for the proposed well to be known as the Cain #17 Well.
2. Applicant owns all the acreage within the Non-Standard Unit, as indicated on Exhibit A attached hereto and made a part hereof. Operators owning offsetting acreage are Pubco Petroleum Corporation and Delhi-Taylor Oil Corporation, and each has been furnished a copy of this Application with a request that their consent in the form of a waiver of notice and hearing be forwarded to the Commission.
- ✓ 3. The Non-Standard Unit consists of contiguous quarter-quarter sections or lots.

- ✓ 4. The Non-Standard Unit lies wholly within a single governmental section.
- ✓ 5. The entire Non-Standard Unit may reasonably be presumed to be productive of gas.
- ✓ 6. The proposed Non-Standard proration unit consists of 152.74 acres and the unorthodox size of the tract is due to a variation in legal subdivision of the U. S. Public Land Survey.

Applicant respectfully requests that this Application be promptly considered and that approval be administratively granted, pursuant to Rule 5(B) of Order R-1670, for the Non-Standard Unit above described.
