Tenneco Oil Company requests administrative approval of the following:

1. The establishment of a 91.50-acre proration unit in the Cha Cha Gallup pool to be dedicated to the Callow "C" Oil Unit No. 1. This unit is to consist of 80 acres, being the E/2 NW/4 Section 31, T. 29 N., R. 13 W., operated by Tenneco plus 11.5 acres, being the W/2 NW/4 Section 31, T. 29 N., R. 13 W., operated by Elliott, Inc. Tenneco Oil Company has drilled and completed a well located 810' FNL and 890' FWL Section 31, T. 29 N., R. 13 W., which was drilled as Tenneco's USA Glenn H. Callow "B" No. 4. This well will be re-named the Callow Oil Unit "C" No. 1 upon approval of this request. The communitization of the above acreage has been approved by the USGS contingent upon the approval of the non-standard proration unit by the NMOCC.

2. ~~Exception from Rule 309-A~~ for the purpose of commingling production from this well with production from Tenneco's Callow "B" lease as shown on the attached plats. Also attached is a schematic diagram showing facilities for metering and storage of production from this well. The equipment to be used is as follows:

- a. Separator, 30" x 10', 125 psi, vertical oil and gas separator
- b. Strainer, Fisher 2" type 260-C
- c. Meter, 1-1/2", 150 psi, Pittsburgh crude oil meter








