Mack Energy respectfully requests an administrative approval without notice and hearing of the following unorthodox well location.

Because of our desire to drill this well in a timely manner, we also request your approval be expedited. The well location and legal description is as follows:

Everest Federal #2
990 FSL & 1600 FEL
Sec. 25, T9S, R29E
Chaves County, New Mexico

The well will be completed in the Wolfcamp formation in the Many Gates:Wolfcamp Pool.

Attached to this application are the following exhibits.

- A.) Well location and acreage dedication plat (form C-102)(Exhibit A).
- B.) A plat showing the proposed unorthodox locations, the respective proration units, and the offsetting proration units (Exhibit B).
- C.) A map showing the reason for the unorthodox location, the original location was too close to an existing archaeological site(LA-167038). BLM requires a 100' buffer from the edge of location to the arch. site. (Exhibit C).

Moving the location 50' to the east will give the distance needed for the 100' buffer area. This location is located on lease NMNM-121943, which is owned 100% by Mack Energy. The acreage that we are encroaching upon is also part of this lease therefore no offset operators need to be notified.







Figure 1: Survey Area **Mack Energy Corporation**






