Pursuant to Division Rule 104.F(2), Devon Energy Production Company, L.P. ("Devon") applies for administrative approval of unorthodox oil well locations for the following wells in both the San Andres formation (~~South~~ Red Lake Queen-Grayburg-San Andres Pool) and Glorieta/Yeso formations (~~Undesignated~~ Northeast Red Lake Glorieta-Yeso Pool):

Devon requests approval of simultaneous dedication of this well unit (in the San Andres formation) with the existing Eagle 34F Federal Well Nos. 23 and 24.

Both the ~~South~~ Red Lake Queen-Grayburg-San Andres Pool and Northeast Red Lake Glorieta-Yeso Pool are developed on statewide rules. Form C-102's for the wells are attached as Exhibits A-1, A-2, and A-3.

The application is based on engineering and topographic reasons. Attached as Exhibit B is a well plat of Glorieta-Yeso wells drilled or being drilled by Devon in Sections 34 and 35. Devon has an ongoing program to develop the Glorieta/Yeso by drilling two wells in each quarter-quarter section, in a northeast-southwest pattern. Wells are being placed in the northeast and southwest corners of each well unit to equalize the distance between the wells.

Attached as the fourth page of each of Exhibits A-1, A-2, and A-3 are survey plats of the well units. There are pipelines, lease roads, and electric lines requiring the wells to be moved from orthodox locations, requiring the wells to be unorthodox to remain in the northeast-southwest pattern.

The locations are based on the Glorieta/Yeso, but since the wells will also penetrate the San Andres, Devon will also attempt completions in that zone.

Attached as Exhibit C is a land plat, highlighting the three well units. The following leases are involved:
