Re: Application of Mewbourne Oil Company for Administrative Approval of an Unorthodox Well Location for its Bradley "28" Federal Com Well No. 2H, to be drilled from an unorthodox surface location 1580 feet from the North line and 65 feet from the West line (Unit E) to an unorthodox bottomhole location 1580 feet from the North line and 330 feet from the East line (Unit H) of Section 28, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico.

Dear Mr. Fesmire:

Pursuant to the provisions of Oil Conservation Division General Rule 19.15.15.13 NMAC, Mewbourne Oil Company hereby seeks administrative approval of an unorthodox oil well location for its Bradley "28" Federal Com Well No. 2H to be drilled as a horizontal well at a point 1580 feet from the North Line and 65 feet from the West line to a true vertical depth of approximately 8278 feet with a measured depth of approximately 12869.63 feet and then in an easterly direction with a lateral length of approximately 4882.28 feet to a bottomhole location 1580 feet from the North line and 330 feet from the East line of Section 28, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico. This well will evaluate the Second Bone Sand interval in the Bone Spring formation which is the principal objective in the well. A 160-acre spacing and proration unit comprised of the S/2 N/2 of Section 28 will be dedicated to the well in the Bone Spring formation.

This well is governed by the Special Rules and Regulations for the Santo Nino-Bone Spring Pool¹ which provide for oil wells to be located on standard spacing units containing 80-acres

¹ Mewbourne has requested that this well be placed in the South Leo-Bone Spring Pool that is governed by the General Rules and Regulations of the Oil Conservation Division which provide for oil wells to be located on standard spacing units containing 40-acres with wells to be located no closer than 330 feet to from the outer boundary of the spacing unit (19.15.15.9 NMAC). If this request is granted, the well, as proposed, will remain unorthodox toward the north and west lines of the dedicated horizontal well project area. Copies of Mewbourne's Notice of Intent – Federal Form OMB Nos. 1004-0135 and 0136 are attached hereto as Exhibits D and E.



with wells to be located within 150 feet of the center of a governmental quarter-quarter section or lot [Order No. R-8546]. This well location is unorthodox in the Bone Spring formation because it is 65 feet from the West line of the project area boundary which is closer to than permitted by the applicable rules. The location is also unorthodox because it is 260 feet from the North line of the project area – or 250 feet closer than allowed.

This unorthodox oil well location is required for topographic reasons. [Topographic Map attached as Exhibit F] The well was originally staked at a standard location 1780 feet from the North line and 330 feet from the West line of Section 28 which was in a large sand dune feature and was denied by the Bureau of Land Management. The proposed unorthodox location is in smaller sand dune feature and has been approved by the BLM. Attached hereto as Exhibit A is a plat showing the location of the subject spacing unit, the proposed unorthodox well location and adjoining spacing units and wells. Exhibit B is a copy of the Acreage Dedication Plat for the well (Division Form C-102) that shows the survey location of the well.

Exhibit C is a list of affected persons as defined in Paragraph (2) of Subsection A of 19.15.4.12 NMAC. A copy of this application, including all attachments, has been mailed to each of these offset operators/affected persons by certified mail-return receipt requested in accordance with Rule 19.15.4.12 A (2) (a). Each owner has been advised that if it has an objection to this application it must be filed in writing with the Division's Santa Fe office within twenty days from the date this notice was sent.






