ChevronTexaco, Exploration & Production Company, formerly Chevron U.S.A. Production Company, respectfully requests administrative approval to add the Grayburg formation production, to the existing E.A. Sticher Battery.

ChevronTexaco would like to 'Pool Surface Commingle' the production from the four (4), Sticher wells to the E.A. Sticher Battery. The E.A. Sticher well # 2 and # 3 will produce in the Grayburg formation and the production will be continuously metered prior to commingling with the well # 1 & # 4, in the battery.

The E.A. Sticher # 2 was recompleted in the Grayburg formation, in September, 2002, and is currently shut-in pending OCD administrative approval. The E.A. Sticher # 3 is currently producing in the Tubb Oil and Gas (Oil) pool and will be recompleted in the Grayburg, in mid November, 2003. The Tubb formation will be permanently isolated with a CIBP set above the Tubb formation. The recompletion to produce the # 2 & 3 in the Grayburg formation has been negotiated with the working interest owners. ChevronTexaco does not intend to produce the Grayburg formation in the E.A. Sticher # 2 or # 3 wells, until OCD administrative approval is received.

The attachments include the well location information, well test, lease map, Working Interest Owners letter, and a schematic diagram of the Sticher battery. It is anticipated that the Sticher # 3 will produce approximately 20 barrels a day, the same as the Sticher # 2, as can be seen on the # 2 well test. ChevronTexaco owns 50% working interest in wells # 2 & # 3, in the Grayburg formation, and 100% working interest in the E.A. Sticher wells #1 and # 4.

For your convenience, I have enclosed a stamped self-address envelope to have the OCD decision sent directly to me, to accelerate the distribution, and so the field can activate the two Grayburg wells. If you have any questions or need additional information, please contact me at 432-687-7384.

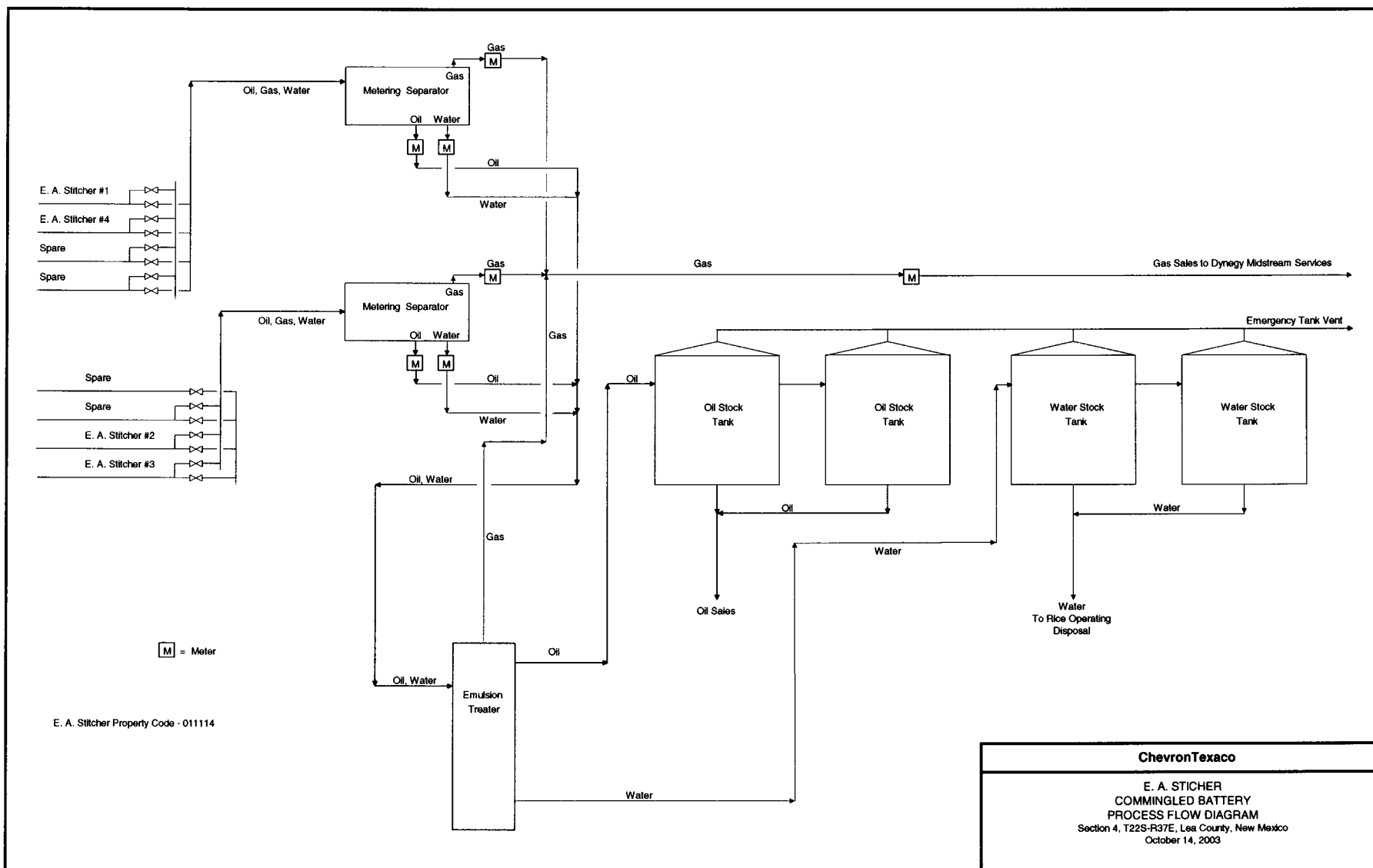

Carolyn:

I double checked with our Division attorney on this subject. Rule 303 made no provision for subWI owners to handle their ORRI owners and RI owners. Practically speaking, it seems that most of the time an operator of a spacing unit sends the revenue checks directly to all ORRI and RI owners of record in the spacing unit.

Therefore:

As the operator of the commingle battery, ChevronTexaco is responsible for notifying all interest owners including all WI, ORRI, and RI owners of record. Please send a list of all these owners and let me know the date they were notified of this consolidation into this battery. By our rules, I must wait 20 days from that date and then can release the administrative order.
