I received your application on December 8, 2003.



Reference is made to Henry Petroleum LP's application for a surface commingle permit authorizing the commingling of production from the State "Y", the W.N. Wimberly and the Ida Wimberly properties at the State "Y" battery site. It is requested that the permit cover production from both currently producing wells and from wells which are later re-completed into zones with common ownership within said properties.

By e-mail message to Ms. Shirley Houchins of this office dated January 12, 2004, you requested a letter verifying that all wells within each of the properties have identical working, mineral and royalty ownership. Please be advised of the following ownership;

1. State "Y": N/2 NE/4 and SE/4 NE/4 Section 25-25S-37E. The two currently producing wells on the property; the #8 and the #11, have identical mineral, working and royalty ownership,
2. W.N. Wimberly: ^{A, C, F} E/2 NW/4 and NW/4 NE/4 Section 23 and N/2 NW/4 and SW/4 NW/4 Section 24-25S-37E. The three currently producing wells on the property; the #9, the #11 and the #12, have identical mineral, working and royalty ownership,
3. Ida Wimberly: W/2 SW/4 Section 24, NW/4 and SW/4 NE/4 Section 25 and NE/4 NE/4 Section 26-25S-37E. The four currently producing wells on the property; the #11, the #13 and the #20 (which produce from one reservoir) and the #22 (which produces from a separate reservoir), have identical mineral, working, and royalty ownership.


