Donna Mull with the OCD in Hobbs called January 25 to tell me that our recompletion into the Penn on the captioned well was placed in error by the district geologist into the Martin Upper Penn North Pool. It should have been placed in the Martin Upper Penn South Pool.

Donna asked that I write to you and ask for a correction.

Also, Administrative Order NSL-6111 was for an unorthodox oil well location for the North Morton-Permo Upper Penn Pool (47350). Since that time, we have recompleted to the Wolfcamp. We respectfully request that the Administrative Order NSL-6111 be amended to include the Morton Wolfcamp Pool (47370).
