



Describe Cause of Problem and Remedial Action Taken.*
The water pump froze and the alarm system malfunctioned due to freezing temperatures. The water pump has thawed and returned into service and the alarm system malfunction has been repaired.

Describe Area Affected and Cleanup Action Taken.*
Initially 17bbls was released from the water tank at the facility and we were able to recover 15bbls with a vacuum truck. The release was completely contained inside the facility walls and the entire facility is lined with 40mil plastic. Contaminated gravel has been removed, tank has been steam cleaned, and fresh gravel will be added to the facility as necessary.
