

Describe Cause of Problem and Remedial Action Taken.*

Due to a new well being turned on, there was an unexpected influx of water that neither the water trucks nor the transfer pumps were able to keep up with. This caused the water tank to overflow.

Describe Area Affected and Cleanup Action Taken.*

Initially 180bbbls of produced water was released from the water tanks at the Folk Federal Tank Battery. We were able to recover 160bbbls with vacuum trucks. The water ran onto the location 60' x 60' and traveled down the lease road 20' x 90'; It then went off into the pasture 3' x 150'. The location and lease road were immediately scraped of contaminates and returned to their prior condition. Tetra Tech will sample the spill site area in the pasture to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD / BLM for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
