The proposed method for remediation at the above referenced site is as was agreed on at our meeting on 3/29/2011 and is approved with the following conditions/stipulations:

- Notify OCD 48 hours prior to backfilling the excavation.
- Should additional soil testing be necessary, notify OCD 48 hours prior to obtaining samples.
- Submit a closure report and Final Report Form C-141 upon satisfactory completion of project.

Approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
