Dear Mr. Henry:

The New Mexico Oil Conservation Division (OCD) has received Plains' report and request for amendment to the Abatement Plan (AP-96) at the above-referenced site (dated August 2010). The above-referenced report, submitted in partial fulfillment of 19.15.30.19 NMAC (Part 30.19, formally, Rule 19.K), indicate that Plains has partially met the requirements of 19.15.30.9 NMAC for this site. Therefore, the OCD hereby conditionally approves the Amendment to the Stage 2 Abatement Plan (AP-96) as proposed for the Lovington Gathering WTI Release Site:

1. Plains must initiate groundwater recovery from groundwater monitoring well, MW-10, in lieu of MW-9, within 5 days.
2. Plains must sample groundwater monitoring well, MW-4, and analyze for chromium and fluoride at the next quarterly sampling event.
3. Plains must include in the quarterly sample program the irrigation well approximately 100 feet to the SSW of MW-10 at the next quarterly sampling event.
4. Plains must submit to the OCD a quarterly groundwater monitoring report within 30 days after each respective quarter.
