Mesquite SWD would respectfully request an extension to the completion and commencement injection date for the Big Eddy deep well. Mesquite had considerable delays in the BLM permitting process, combined with Potash considerations, that have cascaded into re-finding big rig availability, and BLM operational time restriction problems that will not allow re-entry and completion until beyond the August 14, 2011 deadline. Your consideration is respectfully requested.
