On January 4, 1956, we wrote Mr. E. S. Walker, State Land Commissioner of New Mexico, and advised that we were considering the commingling of production from our New Mexico State "AE" Lease with production that may be developed from our New Mexico State "AN" Lease. At the present time we have one oil well on our New Mexico State "AH" Lease producing from an undesignated field. Well No. 1 is now being drilled on our New Mexico State "AN" Lease. Mr. Walker, by his letter of January 6, 1956, advised that his office granted permission to commingle the two leases.

We realize that to commingle the production from two leases it is necessary to secure an exception to Rule 309 of the New Mexico Oil Conservation Commission Rules and Regulations.

To support our request for an exception to Rule 309, we submit the following information:

1. The production from each lease will be estimated on the basis of individual well tests and will be allocated back to each lease.
2. The production to be commingled will be from the same zone and of similar quality.
3. The production from each lease will be in paying quantities.

The description of the leases are as follows:

New Mexico State "AN", Co. Lease No. 120695, State E-735, described as the NE/4 of Section 36, T-15-S, R-34-E, Lea County, New Mexico

New Mexico State "AH", Co. Lease No. 116587, State E-604, described as the S/2 of Section 36, T-15-S, R-34-E, Lea County, New Mexico

We would appreciate your handling this request by administrative approval if this is possible. If an administrative approval is not possible, then we would appreciate your scheduling this for the next hearing date, either an examiner hearing or the regular hearing.




