Re: Exception to N.M.O.C.C. Rule 309 (a)

Gentlemen:

Tennessee Gas Transmission Company requests permission to use one central tank battery to serve three separate, contiguous state oil leases located in Sections 21 and 28, T-16-S, R-34-E, NMPM, Kemnitz Wolfcamp Field, Lea County, New Mexico. These leases are the State "B" lease (State of New Mexico OG-377 covering the NW $\frac{1}{4}$ of Section 21), the State "C" lease (State of New Mexico OG-378 covering the SW $\frac{1}{4}$ of Section 21), and the State "D" lease (State of New Mexico OG-380 covering the NW $\frac{1}{4}$ of Section 28). The leases, the tank battery location and the offset operators are shown on the attached plat.

At the present time, two wells are producing on the State "B" lease, one from the Wolfcamp zone and one from the Cisco. Separate batteries have been installed for each of these wells. Permission is requested to use one central tank battery to handle all production from the Wolfcamp zone only as additional wells are completed on the State "C" and State "D" leases. Development drilling is expected to begin on the State "C" lease in the near future.

Attached are letters consenting to this proposal from all offset operators and the State Land Commissioner, as required by Rule 309 (b).






