

It is requested that the Secretary-Director of the New Mexico Oil Conservation Commission grant an exception to Rule 309(a) to permit the commingling of production from the Roberson #4 well located in the SW/4 SE/4 of Section 25, Township 27 North, Range 13 West, bearing federal serial number SF 078391-A and Roberson #1, #2, #3 wells located in the NE/4 of adjoining Section 36, Township 27 North, Range 13 West and bearing federal serial number SF 078391, into a common tank battery. As your records may reflect, income from these wells is such that all expenses must be kept at a minimum. At the present, wells #1, #2, and #3 are producing through a separator and into a tank battery. The gas from the separator is sold to El Paso Natural Gas Company. The production from #4 feeds directly into a separate tank in the battery and the gas is vented. If permission is granted to commingle production from these wells, we will be able to connect this well to the separator and conserve this gas without any additional expense.

These leases are contiguous and the production is from the same common source of supply. The ownership of the leases is common throughout. Enclosed is a copy of a letter from the royalty owner consenting to the commingling. The United States Geological Survey has given written permission to commingling the production from these four wells, copy of which is attached.






