The Wilson Oil Company, applicant herein, is the operator of New Mexico State Lease B-1167 consisting of E/2NE/4 Sec. 13, T 21 S, R 34 E, and Lease B-1400 consisting of W/2NW/4 Sec. 18, T 21 S, R 35 E, Wilson Pool, Lea County, New Mexico. The royalty from each of the said leases is held for the common school fund.

It is respectfully requested that the Oil Commission, by executive order, grant an exception to state wide rule 309-A for centralization and comingling of oil produced from the four wells located on the leases listed above.

Please be assured that adequate tankage, testing facilities and other equipment will be maintained so that production from each of the four existing wells can be adequately determined at reasonable intervals.

Attached hereto is a letter from the State Land Office signed by Mr. E. S. Walker, Commissioner of Public Lands, granting permission to comeingle oil from State Leases B-1167 and B-1400.
