

Gentlemen:

Reference is made to your application dated August 16, 1962, for administrative approval of an exception to Rule 309-A to permit the commingling of oil produced from your New Mexico State "BO" Lease comprising the E/2 of Section 12, Township 18 South, Range 34 East, and your State "BP" Lease comprising in part the E/2 SW/4 of section 7, Township 18 South, Range 35 East, Vacuum-Abo Pool, Lea County, New Mexico.

It is our understanding that the ownership of each lease is common throughout and that the State land beneficiary under each lease is identical.

Under the authority granted me pursuant to Rule 309-B, you are hereby authorized to commingle the above-described production as proposed, allocating the production to each lease on the basis of periodic well tests, and subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities."

Dear Sir:

Humble Oil and Refining Company requests administrative approval to commingle Abo oil production from its New Mexico State "BO" and "BP" leases, Vacuum Abo Pool, Lea County, New Mexico.

The New Mexico State "BO" lease includes the <sup>East</sup> west one half of Section 12, T-18-S, R-34-E, Lea County, New Mexico and presently has three Abo producing wells, one drilling and one location staked. The State "BP" lease includes the east half of the southwest quarter of Section 7, T-18-S, R-35-E. It has no Abo production at this time; however, application has been made to drill and complete State "BP" No. 2 as a Vacuum Abo producer.

Since both leases have common royalty interests, the State of New Mexico, it is requested that the New Mexico State "BO" and "BP" leases be allowed to produce into common storage with each well prorated on the basis of well tests.

The attached plat shows the location of the present tank battery, producing wells, and proposed locations to be drilled.

Dear Sir:

We have no objection to your proposed commingling of the Abo production from your State BO and BP Leases covering acreage in Section 7 and Section 12, Township 18S, Range 34E, Lea County, provided commingling would not lessen the specific gravity or the State's royalty. Of course we can see no reason why there should be a change in gravity or value. All of Sections 7 and 12 belong to the Common Schools of New Mexico and we have no royalty division problem. The only probable problem would be the amount of production from wells on separate leases. You understand of course that each lease must be producing commercially in order to be extended beyond their ten year term.

In the future we would appreciate it if you would give us the State lease numbers so that we will be able to check these leases properly.


