Gentlemen:

Tenneco Oil Company requests permission to commingle production from the USA-Ernest LC 062269-E Lease, NW/4 of the NW/4, Section 23, T-24-S, R-32-E, Lea County, New Mexico, and the U.S. Smelting-USA LC 062269-A Lease, W/2 of the NW/4, W/2 of the NE/4, E/2 of the SW/4, E/2 of the SE/4, Section 22, T-24-S, R-32-E, Lea County, New Mexico, Double "X" Delaware Pool.

Attached is a location plat and a schematic diagram of the commingling facilities designed in accordance with the Commission's Manual for the Installation and Operation of Commingling Facilities. The tank battery will be located on the U.S. Smelting-USA Lease. Present facilities will be expanded to conform with the attached schematic.




