Gentlemen:

Reference is made to your application of May 10, 1963, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Maljamar (Grayburg-San Andres) Oil Pool production from your Miller EX Lease comprising E/2 of Section 14, Township 17 South, Range 32 East, Lea County, New Mexico, with the Maljamar (Grayburg-San Andres) production from that portion of your Miller B Lease lying outside the participating area of the Maljamar Cooperative Area Unit being the N/2 NE/4 of Section 23, Township 17 South, Range 32 East, Lea County, New Mexico.

It is our understanding that the working interest and royalty interest underlying each of these leases is common throughout and that you therefore propose to commingle the production after separately metering the Miller B Lease production and determining the Miller EX production by means of the subtraction method.

Under the authority granted me pursuant to Rule 309-B, you are hereby authorized to commingle the above-described production as proposed, subject to the provisions of the Commission "Manual for the Installation and Operation of Commingling Facilities," including the requirement for non-reset counters on the meters.
