Gentlemen:

Standard Oil Company of Texas, A Division of California Oil Company, respectfully requests administrative approval to commingle production from its State 4-27 (B-1840) Lease with production from the State 6-34 (B-1845) Lease. All of this production has the same formation origin (Abo) with identical working interest and royalty interest. Production will be via an automatic custody transfer unit located approximately 1200 feet from the South line and 1200 feet from the West line of Section 34, Range 35 East, Township 17 South, Lea County, New Mexico.

The State 4-27 Lease at the present time contains only one producer, the No. 8 well. We are now drilling the No. 9 well which will probably be the only additional Abo producer on the lease.

Production will be prorated to the State 4-27 producer(s) through periodic well tests utilizing the test separator located at the LACT unit on the State 6-34 Lease.

Attached are a purchaser's waiver from Texas-New Mexico Pipeline Company, a lease plat showing well locations and a schematic diagram of the commingling facility.

A copy of this application is being sent to the Commissioner of Public Lands for the State of New Mexico for his approval.

Please advise if we can supply additional information in regards to this proposal.

WAIVER OF OBJECTIONS BY PURCHASER
TO COMMINGLING OF OIL PRODUCTION

TO: New Mexico Oil Conservation Commission

This is to state that the undersigned has been advised of the proposal by Standard Oil Company of Texas, A Division of California Oil Company, for commingling of produced oil from the Abo formation of their State 4-27 (B-1840) Lease with Abo production from their State 6-34 (B-1845) Lease. All wells are located in the Vacuum (Abo) Field of Lea County, New Mexico.

It is understood that Abo production from the State 4-27 Lease will be commingled with Abo production on the State 6-34 Lease and processed through an existing LACT unit. Production from the State 4-27 Lease (at present one well with probable maximum of two wells) will be prorated by utilizing periodic well tests through a test separator at the tank battery.


The undersigned waives any objections to the carrying out of such commingling practices as stated above.
