Dear Sir:

In the Commission's Administrative Order CBT-120, Phillips Petroleum Company was granted authority to commingle oil produced from the Vacuum Glorieta Pool on the following leases: State B-1497 Lease, NW/4 and SW/4 NE/4, Section 26, and the S/2 SW/4 of Section 27; State B-1608 Lease, N/2 NE/4 of Section 33; State B-2517 Lease, SW/4 NW/4 of Section 33; and State B-2862 Lease, NE/4 SW/4 of Section 33, all in Township 17 South, Range 35 East, Lea County, New Mexico. The leases, well numbers and locations of the wells covered by this Order are shown on Attachment I.

In addition to the above leases, we hereby apply for your approval to extend Administrative Order CTB-120 to include commingling of oil produced from the Vacuum Glorieta Pool on the following leases: State B-1861, NE/4 SW/4 of Section 29; State B-1501, SW/4 NE/4 of Section 29; State B-2131, SE/4 NE/4 of Section 29; State B-2498 NW/4 of Section 28; and State B-2224, NE/4 NE/4 of Section 28, all in Township 17 South, Range 35 East, Lea County, New Mexico. The leases, well numbers, locations of the wells and present status of the wells included in this supplement are shown on Attachment II.

Oil production from all of the wells in this application will be from the Glorieta formation, Vacuum Glorieta Pool. It is our plan to establish a field header for the additional wells in Sections 28 and 29 in the SE/4 NW/4 of Section 28 and then run a 2" test line and 3" production trunk line to Battery No. 17. A diagram is attached showing the present equipment and testing facilities in this battery.

Each of these leases has a common working interest and the royalty interest is also common throughout. The allocation of production to each of the leases will be on the basis of periodic well tests. A copy of the Commissioner of Public Lands' letter of approval to commingle oil produced from these leases is attached.



Gentlemen:

Pursuant to our conference of May 28, 1964, please be advised that Phillips Petroleum Company is granted temporary approval from this office to commingle production on portions of the five above-mentioned state leases into one common storage facility. Phillips may proceed upon this approval with the knowledge that the Commissioner is now reviewing the policy regarding commingling and that upon this review various changes may be required pursuant thereto.

The State Land Office has not received the schematic diagram of the commingling operation in question. Please forward this at your earliest convenience, and any other pertinent data that will assist our office. This approval is contingent upon the condition that the Oil and Gas Division shall be notified of any changes or alteration in the system design. Upon completion of the installation of the common tankage equipment and accessories, but before it is put into operation, we should like to request that Phillips notify this office of the completion so that an inspection of the installed equipment might be accomplished.
