- B-2862 - NE/4 SW/4, Sec. 33.
- B-1861 - NE/4 SW/4, Sec. 29.
- B-1501 - SW/4 NE/4, Sec. 29.
- B-2131 - SE/4 NE/4, Sec. 29.
- B-2498 - NW/4 Sec. 28.
- B-2224 - NE/4 NE/4, Sec. 28.


All located in T-17-S, R-35-E, Lea County, New Mexico.

We respectfully request permission to add lease B-2519 described as NE/4 of Sec. 34, T-17-S, R-35-E to this commingling system in order that we may produce our Santa Fe well #113 into this common LACT battery. Our letter of October 1, 1964, transmitted a diagram of the commingling facilities which served this lease at this battery.

We attach a revised lease plat showing the above properties as those being served by this LACT unit as well as a photo copy of the Land Commissioner's letter of September 24, 1965, which approved this proposed amendment to our commingling permit.

Gentlemen:

We have received your letter of September 3, 1965, requesting approval to commingle production from State Lease B-2519 comprising the Northeast Quarter of Section 34, Township 17 South, Range 35 East, Lea County, New Mexico, into Phillips' LACT unit, known as your Santa Fe Battery No. 17. As we understand it, you propose to commingle production from the above described acreage with production from State Leases B-1861, B-1501, B-2498, B-2224, B-1497, B-1608, B-2517, B-2862 and B-2073, all located in Township 17 South, Range 35 East, Lea County, New Mexico.

Due to the fact that there is only one state beneficiary involved, the Commissioner of Public Lands under the authority granted to him hereby issues his approval for commingling production from the subject acreage into Phillips' LACT unit, known as the Santa Fe Battery No. 17. This approval is subject to being withdrawn at the discretion of the Commissioner of Public Lands if he deems the operation to be either unprofitable or otherwise against the best interests of the State of New Mexico.


