


Dear Mr. Porter:

In accordance with the provisions of Rule 303 (b) of the New Mexico Oil Conservation Commission Rules and Regulations, application is hereby made for exception to Rule 309-A to grant permission for the commingling of the production from the subject leases.

The production obtained on the two leases is from a common pool, the Bough "C" Formation, and all ownership and royalty interests are common and identical to both leases. The present daily volume of liquid hydrocarbons produced is approximately 320 barrels. Attached hereto is a plat showing the location of all wells on our leases and the location of the tank battery, together with a schematic diagram of the proposed installation. Adequate testing facilities will be installed to permit the determination of the producing capacity of each well at least once per month. By copy of this letter, the New Mexico State Land Commissioner is requested to consent to this application and to notify you.




