
Under above order number, TEXACO Inc. was authorized to commingle oil produced from the Vacuum (Abo Reef) Pool on the New Mexico "AE" Lease, all of Section 11 and W/2 of Section 12; New Mexico "AC" State (NCT-1) Lease, S/2 of Section 2; and New Mexico "R" State (NCT-3) Lease, S/2 of Section 1, all in Township 18 South, Range 34 East, Lea County, New Mexico, after separately metering the production from each lease.

Production from the Vacuum (Abo Reef) Pool on the New Mexico "AC" State (NCT-1) Pool has ceased, therefore, it is respectfully requested that Administrative Order No. CTB-124 be amended to delete the Vacuum (Abo Reef) production from the New Mexico "AC" State (NCT-1) Lease from the commingling authority. Vacuum (Abo Reef) production from the New Mexico "AE" State and New Mexico "R" State (NCT-3) Leases will continue to be metered prior to commingling as the royalty beneficiaries are different.
