Gentlemen:

In accordance with New Mexico Oil Conservation Commission Rule 309-B, TEXACO Inc. respectfully requests administrative approval of an exception to Rule 309-A to permit commingling of hydrocarbon production from the Moore (Devonian) Pool between State of New Mexico "BO" Lease consisting of the NW/4 of Section 24 and SW/4 of Section 13 and State of New Mexico "BR" Lease consisting of the E/2 of SW/4 of Section 24, Township 11 South, Range 32 East, Lea County, New Mexico. In support of this request the following is stated:

1. TEXACO Inc. is owner and operator of both subject leases and all working and royalty interests are common. Royalty ownership is held by the State of New Mexico and a copy of this application is being sent to the State Land Office at P. O. Box 1148, Santa Fe, New Mexico.

2. Texas-New Mexico Pipe Line Company is the purchaser and a copy of this application is being furnished them at P. O. Box 1510, Midland, Texas.

3. All production is from a common source of supply, being the Devonian reservoir.

4. Adequate metering test facilities shall be provided for determining the producing capacity of each well at least once each month.


5. Production from each well shall be reported separately each month based on well test capacity.

6. A schematic diagram of the proposed commingling installation and plat of the leases showing all wells and formations in which they are completed are attached.

7. Application for ACT installation and use shall be made after receiving the requested permit for commingling.

Your early consideration to grant the requested permit to commingle hydrocarbon production from the Moore (Devonian) Pool on TEXACO Inc.'s State of New Mexico "BO" and State of New Mexico "BR" Leases would be appreciated.



Lea County, New Mexico


