Gentlemen:

Your letter of October 21, 1964, requests our approval to commingle the Strawn formation oil and gas produced from Tenneco Oil Company's No. 1 USA - Hudson and No. 1 USA - Continental "B" Unit wells. The wells are located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ sec. 5 and SE $\frac{1}{4}$ NW $\frac{1}{4}$ sec. 6, T. 19 S., R. 32 E., Lea County, New Mexico, on leases New Mexico 0319697 and LC 071857-B, respectively. The production from these wells is to be commingled with that from the No. 1 USA - Continental and No. 1 USA - Continental "A" Unit wells at the central commingling installation approved by our letter of August 18, 1964.

The method of measurement and the system for commingling the oil and gas production from these four wells as discussed by your application and described by the diagram attached thereto, is hereby approved. Such approval is subject, however, to like approval by the New Mexico Oil Conservation Commission and to the requirement that Tenneco file with this office a communitization agreement whereby the NW $\frac{1}{4}$ sec. 6, T. 19 S., R. 32 E., is communitized in a 160-acre tract for the production of oil and associated hydrocarbons from the Strawn formation.

You are also requested to notify the District Engineer, U. S. Geological Survey, P. O. Box 1157, Hobbs, New Mexico, when the additional wells are added to the installation so that a field inspection of the facilities can be made.

Returned herewith are three copies of an instrument entitled "Amendment to Agreement to Commingle Production". The agreement does not require our approval inasmuch as such approval is accomplished by this letter.

SECOND AMENDMENT TO
AGREEMENT TO COMMINGLE PRODUCTION

THIS AMENDMENT, made and entered into this 15th day of February, 1965, by and between Tenneco Oil Company, a Delaware corporation, hereinafter sometimes referred to as "Operator", and the other undersigned parties hereto, hereinafter sometimes referred to as "The Other Parties Hereto".

W I T N E S S E T H, T H A T:

WHEREAS, Operator and certain of The Other Parties Hereto did, under date of August 7, 1964, make and enter into that certain Agreement to Commingle Production, covering and applying to certain lands lying and situated in Township 19 South, Range 32 East, N.M.P.M., Lea County, New Mexico; and

WHEREAS, under date of October 21, 1964, Operator and certain of The Other Parties Hereto did make and enter into that Amendment to Agreement to Commingle Production whereby additional lands lying and situated in Township 19 South, Range 32 East, N.M.P.M. were made subject to the Agreement to Commingle Production dated August 7, 1964; and

WHEREAS, Operator and The Other Parties Hereto desire to further amend the aforesaid Agreement to Commingle Production as hereinafter provided.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations and for the benefits to be derived herefrom, the parties hereto do hereby covenant, contract and agree as follows:

I.

The parties hereto do hereby acknowledge receipt of the Agreement to Commingle Production dated August 7, 1964 and the Amendment to Agreement to Commingle Production dated October 21, 1964 and further acknowledge that they are familiar with the terms, provisions and conditions thereof. Said Agreement and Amendment are hereby incorporated herein by reference with the same force and effect as if the same were set forth herein in full.

II.

Exhibit "A" of the Agreement dated August 7, 1964 as amended by Amendment dated October 21, 1964 is hereby changed to include additional lands which are described in the attached Exhibit "A" as Communitized Areas No. 5 and No. 6. Exhibit "A" shall be the Exhibit "A" which is attached hereto and made a part hereof for all purposes herein.

III.

Except as hereby amended, said Agreement to Commingle Production, as amended by the Amendment dated October 21, 1964, shall be and remain otherwise unchanged in all of its terms provisions and conditions.

IV.

This Amendment may be executed in any number of counterparts with the same force and effect as if all of the parties hereto had executed one and the same instrument and shall be binding upon the parties who execute said instrument, regardless of whether all of the parties hereto execute this instrument or any counterpart thereof.

V.

This Amendment shall be effective as of 7:00 A.M., M.S.T., the _____ day of _____, 19____.

AMENDMENT TO AGREEMENT TO COMMINGLE PRODUCTION

THIS AMENDMENT, made and entered into this 21st day of OCTOBER, 1964, by and between Tenneco Oil Company, a Delaware corporation, hereinafter sometimes referred to as "Operator", and other undersigned parties hereto, hereinafter sometimes referred to as "The Other Parties Hereto".

W I T N E S S E T H, T H A T:

WHEREAS, Operator and certain of The Other Parties Hereto did, under date of August 7, 1964, make and enter into that certain Agreement to Commingle Production, covering and applying to certain lands lying and situated in Township 19 South, Range 32 East, N.M.P.M., Lea County, New Mexico. A copy of said Agreement is attached hereto as Exhibit "A" and made a part hereof for all purposes herein; and

WHEREAS, Operator and The Other Parties Hereto desire to amend Exhibit "A" of said Agreement by the addition thereto of the communitized areas described in the attached Exhibit "B".

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations and for the benefits to be derived herefrom, the parties hereto do hereby covenant, contract and agree as follows:

I.

Exhibit "A" to said Agreement to Commingle Production, dated August 7, 1964, is hereby amended to include therein the tracts of land described in Exhibit "B", which is attached hereto and made a part hereof for all purposes hereof.

II.

Except as hereby amended, said Agreement to Commingle Production shall be and remain otherwise unchanged in all of its terms, provisions and conditions.

III.

This Amendment may be executed in any number of counterparts with the same force and effect as if all of the parties hereto had executed one and the same instrument and shall be binding upon the parties who do execute said instrument, regardless of whether all parties hereto execute the same instrument.

IV.

This Amendment shall be effective as of 7:00 A.M., M.S.T., the 19th day of OCTOBER, 1964.
