Gentlemen:

Tenneco Oil Company requests permission to commingle production from our USA-Trigg Lease, SW/4 of Section 8, T-19-S, R-32-E, and our USA-Moleen Lease, SE/4 of Section 31, T-18-S, R-32-E, both in Lea County, New Mexico, into the presently commingled tank battery of the USA-Continental Unit, USA-Continental "A" Unit and the USA-Hudson Lease (approved by administrative order CTB-129, as amended) being the E/2 of Section 6 and the NW/4 of Section 5 of T-19-S, R-32-E, Lea County, New Mexico, all in the Lusk Strawn Pool.

Attached in triplicate are location plats and schematic diagrams of the commingling facilities designed in accordance with the Commission's Manual for the Installation and Operation of Commingling Facilities. The tank battery is located on the USA-Continental Unit. Present facilities will be expanded to conform with the attached schematic.

Also attached are: letter of consent to commingle from the United States Geological Survey; copy of letter and proof of mailing to all parties owning an interest in the leases along with copy of the commingling agreement; copy of letter from the oil transporter agreeing to the commingling; and, Table No. 1 showing the division of lease ownership.

Your early consideration of this request will be appreciated.






Gentlemen:

Your letter of February 17 requests our approval to commingle Strawn oil production from Tenneco Oil Company's well No. 1 USA-Trigg, in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ sec. 8, T. 19 S., R. 32 E., and well No. 1 USA-Moleen Unit, in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ sec. 31, T. 18 S., R. 32 E., Lea County, New Mexico, on leases New Mexico 0750-A and 0136272, respectively. Production from these wells is to be commingled with that from the No. 1 USA-Continental Unit, No. 1 USA-Continental "A" Unit, and No. 1 USA-Hudson wells at the central commingling installation approved by our letter of November 3, 1964.

The method of commingling described by the diagram attached to your letter is hereby approved, subject to like approval by the New Mexico Oil Conservation Commission.

You are requested to notify the District Engineer, U. S. Geological Survey, P. O. Box 1157, Hobbs, New Mexico, when the additional wells are added to the installation so that a field inspection of the facilities can be made.

Attached are copies of a Second Amendment to the Agreement to Commingle production dated August 7, 1964. The original agreement covered production from the east half of Section 6, T-19-S, R-32-E. The first amendment included the NW/4 of Section 5, T-19-S, R-32-E, into the commingled battery. This amendment is to provide for the inclusion of tracts consisting of the SW/4 of Section 8, T-19-S, R-32-E, and the SE/4 of Section 31, T-18-S, R-32-E. The well in Section 8 is completed and the well in Section 31 is now drilling. In order to begin production from the drilling well upon completion with no delay, you are respectfully requested to expedite signing two copies of the amendment and returning same promptly to Tenneco Oil Company. A fully executed copy will be returned for your files.

The advantages to all working interest and royalty interest owners were set out in the attachments to the cover letter on the First Amendment. The additional income from the installation of a vapor recovery unit at the commingled battery will be advantageous to both royalty and working interest owners.
