Pan American Petroleum Corporation hereby submits application for the commingling of production from separate leases as follows:

Hood Federal Lease, E/2 of NW/4, Section 13, Township 9 South, Range 35 East, NMFM, Lea County, New Mexico. NM-0149958.

Federal "A" Lease, NE/4, E/2NW/4, and S/2 of Section 13, Township 9 South, Range 35 East, NMFM, Lea County, New Mexico. - NM-0450847.

In support of our request for exception to Rule 309-A to permit the commingling of production from two separate leases into a common tank battery without notice and hearing, the following is submitted:

1. Plats of the leases showing thereon the wells and formation in which they are completed.
2. Schematic diagram of the commingling facility.
3. Production is from a common source of supply, Devonian Formation, Bough Devonian Field.
4. Production from each lease will be metered and sampled separately prior to commingling, utilizing A. O. Smith T-6 temperature-compensated meters.




