Gentlemen:

Standard Oil Company of Texas, a Division of Chevron Oil Company, respectfully requests administrative approval to commingle the Glorieta production from the Vac Edge Unit Wells Nos. 1-G and 2-G with the Glorieta production on the State 3-32 lease. Vac Edge Unit Well Nos. 1-G and 2-G are located in Units B and A, Section 5, Township 18 South, Range 35 East, Lea County, New Mexico. The State 3-32 lease is located in Section 32, Township 17 South, Range 35 East, Lea County, New Mexico.

Presently, Glorieta production from Vac Edge Unit Wells Nos. 1-G and 2-G is being commingled with Abo production on the Vac Edge Unit lease located in Sections 3, 4, 5, 9, and 10, Township 18 South, Range 35 East, Vacuum Field, Lea County, New Mexico, under Administrative Order PC-251. In the near future, formation of the Vacuum (Abo) Unit with Phillips Petroleum Company as operator will necessitate certain battery changes in the Vacuum Area. Standard feels that this request, if granted, will allow an orderly transfer of Abo wells to Phillips Petroleum at the time the unit is formed.

Glorieta production from Vac Edge Unit Wells Nos. 1-G and 2-G will utilize on-lease metering facilities prior to transfer to the State 3-32 lease. Glorieta production on the State 3-32 lease will be determined by subtraction with production prorated to individual wells by periodic well tests utilizing metering separators.

Attached are a copy of the letter sent to the purchaser, a copy of the letter sent to all interest owners requesting waivers, a lease plat showing well locations, and a schematic diagram showing the

Gentlemen:

Sinclair purchases crude oil from Standard from several leases in the Vacuum Field Area, Lea County, New Mexico. In the very near future some of Standard's interests in this area will become unitized with that of offset operators. In order to prepare for this unitization it is desirable for Standard to consolidate lease batteries of several of our properties. Sinclair purchases from the bulk of these leases. We would appreciate your concurrence to our making the consolidations indicated below assuming of course, we receive necessary commingling permits from the New Mexico Commission. This would anticipate your making certain additional purchases from Standard, also as indicated:

1. Commingle production from the Vac Edge Unit wells Nos. 18 and 23 with that from the State 3-32 lease. Delivery to be made at the State 3-32 battery. All production is from the Glorieta formation. Cities Service currently purchases the Vac Edge Unit production and Sinclair purchases at the State 3-32 lease. Production involved is:

State 3-32 Lease	257 B/D

2. Commingle production from the State 6-34 (Glorietta) Lease, State 6-34 (San Andres), State 4-27 (San Andres) and the State 5-27 (San Andres) leases. Delivery to be made at the State 4-27 battery. Production involved is:

State 6-34 (San Andres)	215 B/D
State 4-27 (San Andres)	172 B/D
State 5-27 (San Andres)	99 B/D

Sinclair currently purchases all the oil above except the State 6-34 (Glazetta), which is purchased by Cities Service. Although the Glazetta production is sweet (40° API), we assure that Sinclair would purchase it on their sour posting. The average gravity of San Andras production is 30° API.

It is our understanding, from brief conversation with Mr. J. A. Halbert, that Sinclair is willing to consider taking on the additional purchases involved in the above, as well as agreeing to the consolidations. We would appreciate your confirming this after your appropriate review.

Gentlemen:

Standard Oil Company of Texas, a Division of Chevron Oil Company, is applying for administrative approval from the New Mexico Oil Conservation Commission to commingle Glorieta production from Vacuum Edge Unit Well No. 1G and 2G with Glorieta production on the State 3-32 Lease. Standard feels that this is a necessary step to allow orderly formation of the Vacuum (Abo) Unit.

The commingling gathering system will utilize on-lease metering of production from the Vacuum Edge Unit Well Nos. 1G and 2G prior to transfer to the State 3-32 Lease. Presently, production from the Vacuum Edge Unit Well Nos. 1G and 2G is being commingled with the Abo production on the same lease. Installation and operation of the proposed system will be in accordance with the New Mexico Oil Conservation Commission's "Manual for the Installation and Operation of Commingling Facilities".




