Gentlemen:

Reference is made to your letter dated December 6, 1968, wherein you request amendment of Administrative Order CTB-174 to permit the commingling of Cato-San Andres production from your Brown Federal, Brown Federal A, Hodges Federal, and Hodges Federal C Leases in Sections 22, 23, 24, and 26, Township 8 South, Range 30 East, Chaves County, New Mexico. It is our understanding that the Hodges Federal and Hodges Federal C production will be commingled and then separately metered and that the Brown Federal and Brown Federal A production will be commingled and then separately metered, after which the production from all four leases will be commingled.

Administrative Order CTB-174 is hereby amended to permit the commingling of the four above-mentioned leases as described, and Administrative Order CTB-175 which previously authorized the commingling of Brown Federal and Brown Federal A production is hereby cancelled.
