Your letter to Mr. A. L. Porter, Jr., New Mexico Oil Conservation Commission, under date of July 27, 1967, has been forwarded to this office for approval before the OCC reviews the application.

We have reviewed your application to commingle the production from the captioned wells and find that both wells are located on the same State of New Mexico Oil and Gas Lease: No. E-6387, and the wells are producing from the same formation. Authority to commingle is given you in the State of New Mexico Oil and Gas Lease.

Since jurisdiction in this matter vests in the Oil Conservation Commission, your application is being handed to Mr. Dan Nutter of that office in Santa Fe, for whatever action is required.




