

Reference is made to our previous correspondence in regard to the commingling of the Humble "A" #1 and Humble "B" #1 wells located in Sections 26 and 24 of 10S-33E, Lea County, New Mexico.

Your letter of December 4, 1967, required certain additional information and in line with this request we are enclosing a xerox copy of a letter dated December 6, 1967, from the Commissioner of Public Lands approving of the commingling of these two wells. Also enclosed is a xerox copy of a plat showing the position of the pumping units, power oil tanks, stock tanks, etc. and also a xerox copy of a plat showing the relationship of the two state leases.

We have by letters dated December 8, 1967, communicated with Warren, who is the purchaser of the gas, Pan American Petroleum Corporation, who is the purchaser of the oil, and Humble Oil & Refining Company, who owned the deeper rights and overriding royalty on this lease and requested their permission to commingle these two leases. To date we have not received a reply on these communications. As soon as written consent is received it will be forwarded to your office.

This is also to advise that the ownership in the leases both royalty and working interests is common.

We will continue to keep your office advised.

Reference is made to our prior exchange of correspondence regarding the proposed purchase and sale of the casinghead gas production which you are in the process of developing on the above described lease.

Your most recent letter advised that you were securing approval to commingle the gas production from this well with the production from the No. 1 well on the Humble "A" Lease in the E/2 NE/4 Section 26-10S-33E. You further stated that the ownership, both as to the leasehold and mineral interests, is identical as to both properties. We presume that when these wells are commingled that all of the gas will be available at the present battery on the Humble "A" Lease from which we are presently measuring the gas production by our station 46-342. We, of course, will automatically take delivery of the commingled stream at this point.

In view of the above and in order that the attributed acreage can be covered as to the commingled stream of gas, we have prepared and enclose herewith the original and five copies of Casinghead Gas Contract drawn to cover your jointly owned Humble "B" Lease as described in the caption. This form of contract is identical with the agreement which we presently completed with you as to the Humble "A" Lease, such agreement being dated August 11, 1967. Will you please have the enclosure signed on behalf of the various parties listed as Seller, returning all copies to this office. Upon completion of signatures five fully executed copies will be furnished for Seller's files and should additional copies be required, we will be happy to furnish additional reproduced copies pursuant to your instructions.

We also call attention to the fact that this agreement provides for counterpart execution. This will, no doubt, be of assistance to you in securing the acceptance of the various parties Seller. If signatures are secured in counterpart, then copies which we will supply you will contain reproductions of all counterpart signatures. Your early attention to the handling of this agreement will be sincerely appreciated.

Incidentally, should the point of delivery of the commingled stream be other than that which we have outlined above, we would appreciate your advising us at the earliest possible date.



PLAT OF COMMINGLED LEASES


C.B. READ - HUMBLE A & HUMBLE B LEASES
