Gentlemen:

Getty Oil Company respectfully requests approval to commingle the oil production on its State "AW" and State "AX" Leases in accordance with Rule 309-B of the New Mexico Oil Conservation Commission Rules and Regulations.

In support of this application, the following information is submitted:

1. All production is from the Eunice Grayburg San Andres Pool.
2. Working interest ownership and royalty ownership is common for these two (2) leases.
3. Attached is a plat showing the location of the wells and leases.
4. Attached is a schematic diagram of the proposed commingling facility located on the State "AX" Lease.
5. Production is to be allocated based on monthly well tests.

There is only one well on each of these leases. The wells are marginal producers with the State "AW" No. 1 making 6 BOPD and the State "AX" No. 1 making 4 BOPD. The production facilities on the State "AW" must be replaced. In the interest of conservation and for continued economic operation of these leases, Getty Oil Company submits this request to commingle.

A copy of this application has been sent to the New Mexico Commissioner of Public Lands with a letter requesting approval to commingle.






On future commingling applications for State leases, we will attach a copy of the Commissioner of Public Lands approval.
