LEASE NAME: Plains Knight Lease  
DESCRIPTION: N/2 SW/4, SE/4 SW/4, Section 23, Township 24 South, Range 37 East, NMPM

LEASE NAME: Bertha Lease  
DESCRIPTION: SW/4 SW/4, Section 23, Township 24 South, Range 37 East, NMPM

LEASE NAME: Both in Lea County, New Mexico  
DESCRIPTION:

Production shall be allocated to each lease by well tests; (If this method or the subtraction method is to be authorized, all commingled production must be of identical ownership including working interest, royalty interest, and overriding royalty interest.)

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 309-B of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.

REMARKS: This order supersedes Order No. CTB-220 which authorized the surface commingling of Fowler Upper Yeso Pool production from the above described leases.

Reference is made to your application dated March 15, 1971, for administrative approval of an exception to Rule 309-A of the Commission Rules and Regulations to permit the commingling of Fowler Upper Yeso production from your Plains Knight lease comprising the N/2 SW/4 and SE/4 SW/4 of Section 23, Township 24 South, Range 37 East, Lea County, New Mexico with Fowler Upper Yeso production from your Bertha lease which comprises the SW/4 SW/4 of said Section 23, allocating the production on the basis of periodic well tests. It is our understanding that there is no diversity of ownership between the two leases.
