Yates Petroleum Corporation respectfully requests administrative approval for surface commingling, lease commingling, off lease storage and measurement for the following leases:

Matlock AJW #1
Unit J, NWSE
1980' FSL & 1980' FEL
Section 4-T19S-R25E
Eddy County, New Mexico
Fee Lease

Bradshaw #1
Unit P, SESE
660' FSL & 660' FEL
Section 4-T19S-R25E
Eddy County, New Mexico
Fee Lease

The production from the Bradshaw #1 will be transported prior to measurement to a common tank battery located at the Matlock AJW #1 location. A map labeled, Attachment I, is enclosed for your information.

The purpose of this off-lease storage and surface commingling is to reduce operation costs for storage and treating, thereby extending the economic life of each well. Without approval for utilizing existing batteries on adjacent leases, it will become necessary to build separate facilities for each well. This will greatly increase costs and shorten the economic life of the well(s).

Because working interests for the wells are different, oil from each of the wells will be measured by positive displacement, temperature compensated metering equipment prior to surface commingling. Gas from the wells will also be metered separately. This metering will ensure that all production from each of the wells is equitably accounted for with no significant effect on your revenue. The production from the same production zone which is the Canyon.

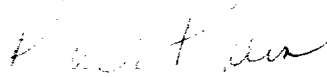

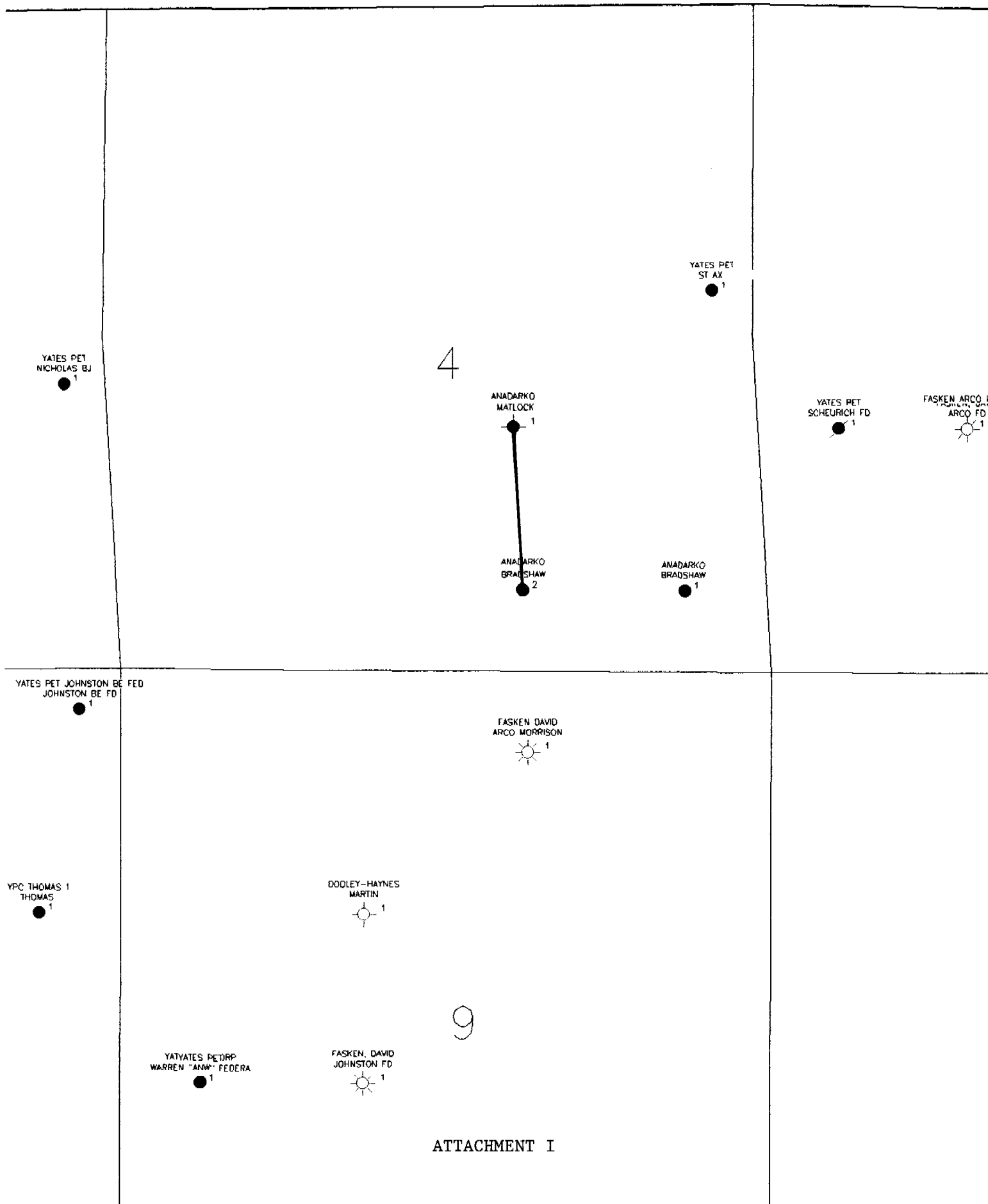

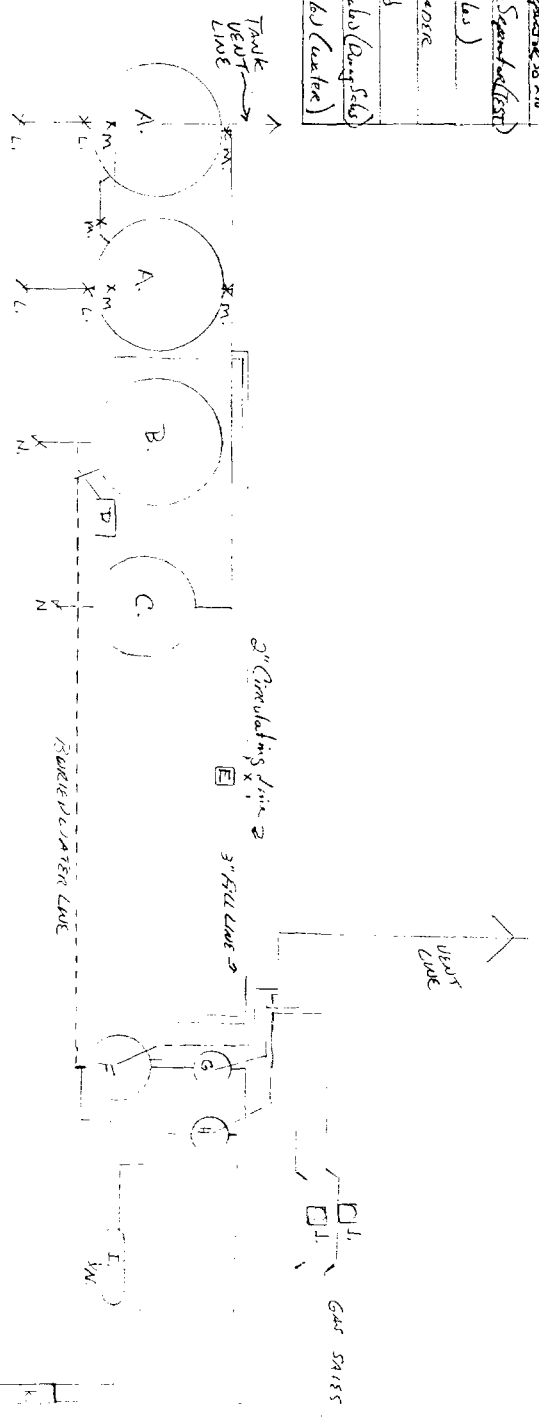
